During this period, steered the company through one of the most difficult periods faced by the steel industry worldwide and in India. This was also the period when the steel industry in India and particularly SAIL, a Public Sector Enterprise faced and survived reform and liberalization which transformed steel in India from the most tightly controlled to the most liberalized industry, moving entirely in line with world trends. Also during this period successfully led the implementation of a major restructuring exercise for SAIL involving, among others, debt rescheduling, cost rationalization, productivity and quality improvements, reorganization of major assets and functions.
