

Final Year / Semester students who expect their final results **by 14.08.2023** are also eligible to apply, provided they have obtained minimum 60% marks or equivalent CGPA in aggregate of all semesters/years up to pre-final examination. In case of selection, their candidature shall be subject to their securing minimum 60% marks in essential qualification.

Such candidates need to mention their marks up to pre-final examination while filling up the online application form for POWERGRID.

SELECTION PROCESS

The Selection Process consists of marks obtained (out of 100) in the corresponding paper of **GATE 2023**, Group Discussion & Personal Interview.

Eligible candidates will have to appear for the **corresponding paper of GATE 2023**, i.e. **Electrical Engineering (EE) / Electronics and Communication (EC) / Civil Engineering (CE) / Computer Science Engineering (CS)**.

Candidates qualified in corresponding paper of GATE 2023 shall only be eligible to be considered for the next stage of selection. Qualifying marks in GATE 2023 shall be as decided by GATE 2023 conducting authority.

Qualified candidates shall be short-listed category-wise for Group Discussion & Personal Interview based on their **normalized marks out of 100** in GATE 2023, in the corresponding paper.

Candidates shall have the option of appearing in the GD/Interview in Hindi or English.

Candidates shall obtain information about their status through their login at the POWERGRID Online Application System. Shortlisted candidates shall be able to download their interview call letter and other relevant documents through the candidate login.



Candidates shortlisted for the Group Discussion and Interview shall be required to bring the documents as mentioned in their interview call letter.

Candidates must qualify in the Personal Interview in order to be considered for empanelment. The qualifying % in interview for different categories is as mentioned below:

Empanelment of Candidates

Candidates shortlisted for GD and interview may have to undergo psychometric assessment results of which shall be used as an input during the interview. Candidates who qualify in the Personal Interview will only be adjudged suitable for empanelment. Therefore, it is again reiterated that candidates will have to qualify in GATE 2023 and in Personal Interview separately in order to be considered eligible for empanelment.

Please note that only GATE 2023 score (Normalized Marks out of 100) is valid for this recruitment process. GATE score of 2022 or prior is not valid.

The offer of appointment shall be issued to the suitable candidates in the order of category wise merit and based on the requirement. Selected candidates shall be notified through their login in Online application system.

Appointment of selected candidates will be subject to their being found medically fit in the Pre-Employment Medical Examination to be conducted as per <u>POWERGRID Norms and Standards of</u> <u>Medical Fitness.</u>

COMPENSATION PACKAGE

The Corporation offers a very attractive pay package and is one of the best in the Industry. Selected candidates will be placed in the pay scale of Rs.40,000/- -3%- 1,40,000(IDA) during the



one-year training period. They shall be paid stipend in the form of Basic Pay of Rs. 40,000/- along with IDA, HRA and Perks @12% of basic pay during training period.

On successful completion of training, the candidates will be absorbed as Engineers in E2 scale - Rs. 50,000/- 3%- 1,60,000/- (IDA).

- SC/ST/PwD/ Ex-SM/ Departmental candidates are exempted from payment of application fees. You are required to login to your candidate login section and then deposit nonrefundable application fees of Rs. 500/- through online mode only. On submission of application fees, your application process will be treated as complete.
- 6. Candidates will be required to retain their GATE 2023 Admit card and GATE 2023 Score card for verification at the time of GD/ Interview /pre-employment medical examination/ Joining in POWERGRID.

- 3. Essential qualification should be recognized in India and from a recognized Institution or University.
- 4. Vacancies are for requirement all over the country, mostly on-site locations. Selected candidates shall be assigned for OJT and final postings accordingly.
- 5. Management reserves the right to cancel / restrict /enlarge / modify / alter the recruitment/ selection process, if need so arises, without issuing any further notice or assigning any reason thereafter.
- 6. Date of issuance of final mark sheet shall be taken as the date of acquiring qualification.
- 7. Wherever CGPA/OGPA/DGPA or Letter Grade in a degree / diploma is awarded, its equivalent percentage of marks must be indicated in the application form as per norms adopted by University / Institute.
- 8. Percentage of marks obtained by the candidate in the bachelor's degree shall be calculated based on the practice followed by the university/institution from where the candidate has obtained the degree. In case the candidates are awarded grades/CGPA instead of marks, the conversion of grades/CGPA to percentage of marks shall be based on the procedure certified by the university/ institution from where they have obtained the bachelor's degree.

In case the university/ institution does not have any scheme for converting CGPA into equivalent marks, the equivalence would be established by dividing the candidate's CGPA by the maximum possible CGPA and multiplying the result with 100.
