6. **Reservation/ Relaxation / Concession for SC / ST** will be subject to submission of relevant Caste Certificate in format prescribed by the Govt. of India for "Appointment to posts under Govt. of India" from a competent authority at the time of application and interview, if called for.

7. **Relaxation / Concession for Victims of riots/Ex-SM** will be as per Govt. of India Guidelines in this regard.

8. **Reservation and Relaxation for OBC (NCL)** will be subject to submission of latest OBC (NCL) certificate in the format prescribed by the Govt. of India for "Appointment to posts under Govt. of India" from a competent authority at the time of application and interview, if called for. The OBC candidates applying for the post must produce OBC (Non-Creamy Layer) certificate based on the income for the Financial Year (FY) 2022-2023, 2023-2024 and 2024-2025 and issued on/after 01.04.2025 (after the completion of FY 2024-25). OBC(NCL) candidates will have to give a self-undertaking, at the time of Personal Interviews (if shortlisted), indicating that they belong to OBC (Non-Creamy Layer).

9. **Reservation for EWS** will be subject to submission of a copy of the latest Income and Asset Certificate issued by a Competent Authority at time of application and interview, if called for. A candidate will be eligible to get the benefit of the Economically Weaker Section reservation only in case the candidate meets the criteria issued by the Central Government and is in possession of requisite Income & Asset Certificate based on income for Financial Year (FY) 2024-2025 and issued on/after 01.04.2025 (after the completion of FY 2024-25). Name of the caste should be clearly mentioned in the aforesaid certificate. Caste name like "General / Samanya" etc. will not suffice.

10. **Reservation / Relaxation / Concession for Persons with Benchmark Disability** is subject to submission of medical certificate in prescribed format in support of permanent disability issued by the Government Medical Board at the time of application and interview, if called for. Candidates must also produce Unique Disability ID (UDID) card/ certificate issued by the Competent Authority.

11. In case Caste/Category certificate is issued in a language other than Hindi or English, candidates are required to produce a certified translation of the same in either Hindi or English language at the time of Document Verification, if called for.

12. SC/ST/PwBD/Ex-SM candidates are exempted from payment of application fee.

Trainees working in POWERGRID shall not be considered as Departmental Candidate. Departmental candidates may please refer to Internal Circular before filling in the application for further details.

SELECTION PROCESS

The Selection Process consists of marks obtained (out of 100) in the corresponding paper of **GATE 2026**, Group Discussion & Personal Interview.

Eligible candidates will have to appear for the **corresponding paper of GATE 2026**, i.e. **Electrical Engineering (EE) / Electronics and Communication (EC) / Civil Engineering (CE)/ Computer Science Engineering (CS)**.

Candidates qualified in corresponding paper of GATE 2026 shall only be eligible to be considered for the next stage of selection. Qualifying marks in GATE 2026 shall be as decided by GATE 2026 conducting authority.

Qualified candidates shall be short-listed category-wise for Group Discussion & Personal Interview based on their **normalized marks out of 100** in GATE 2026, in the corresponding paper and as per the criteria decided by the Management.

Candidates shall have the option of appearing in the GD/Interview in Hindi or English.

Candidates shall obtain information about their status through their login at the POWERGRID Online Application System. Shortlisted candidates shall be able to download their interview call letter and other relevant documents through the candidate login.

Candidates shortlisted for the Group Discussion and Interview shall be required to bring the documents as mentioned in their interview call letter.

Candidates must qualify in the Personal Interview in order to be considered for empanelment. The qualifying % in interview for different categories is as mentioned below:

Empanelment of Candidates

Candidates shortlisted for GD and interview may have to undergo psychometric assessment results of which shall be used as an input during the interview. Candidates who qualify in the Personal Interview will only be adjudged suitable for empanelment. Therefore, it is again reiterated that candidates will have to qualify in GATE 2026 and in Personal Interview separately in order to be considered eligible for empanelment.

Please note that only GATE 2026 score (Normalized Marks out of 100) is valid for this recruitment process. GATE score of 2025 or prior is not valid.

The offer of appointment shall be issued to suitable candidates in the order of category wise merit and based on the requirement. In case two or more candidates secure equal marks, they will be empaneled in the chronological order of their date of birth, the eldest being placed first among them. Selected candidates shall be notified through their login in Online application system.

Appointment of selected candidates will be subject to their being found medically fit in the Pre-Employment Medical Examination to be conducted as per [POWERGRID Norms and Standards of Medical Fitness](#).

COMPENSATION PACKAGE

The Corporation offers a very attractive pay package and is one of the best in the Industry. Selected candidates will be placed in the pay scale of Rs.40,000/- -3%- 1,40,000(IDA) during the one-year training period. They shall be paid Basic Pay of Rs. 40,000/- along with IDA, HRA and Perks @12% of basic pay during training period. The approximate CTC per annum shall be as follows:

After successful completion of Training	Rs. 22.50 lakhs

The CTC shall vary depending on location of posting and other terms and conditions of appointment.

On successful completion of training, the candidates will be absorbed as Engineer in E2 scale - Rs. 50,000/- 3%- 1,60,000/- (IDA).

5. SC/ST/PwBD/ Ex-SM/ Departmental candidates are exempted from payment of application fees. You are required to login to your candidate login section and then deposit **non-refundable application fees of Rs. 500/-** through online mode only. On submission of application fees, your application process will be treated as complete.
6. Candidates will be required to retain their GATE 2026 Admit card and GATE 2026 Score card for verification at the time of GD/ Interview /pre-employment medical examination/ Joining in POWERGRID.

GENERAL INFORMATION AND INSTRUCTIONS

1. Only Indian Nationals of age 18 years or above are eligible to apply for POWERGRID.
2. Before applying, the candidate should ensure that he / she fulfills the eligibility criteria and other norms mentioned in this advertisement.
3. Such graduates who are desirous of pursuing further studies on the basis of GATE 2026 or need extension of joining time in case of selection need not apply.
4. Essential qualification should be recognized in India and from a recognized Institution or University.
5. Vacancies are for requirement all over the country, mostly on-site locations. Selected candidates shall be assigned for OJT and final postings accordingly. Candidates are liable to be posted at the discretion of management to serve at any of the company's offices / establishments / Subsidiaries/ JVs/ units or any other government departments, statutory body or public sector undertaking anywhere in India or abroad.

In case the candidates are awarded grades/CGPA instead of marks, the conversion of grades/CGPA to percentage of marks shall be based on the procedure certified by the university/ institution from where they have obtained the bachelor's degree.

In case the university/ institution does not have any scheme for converting CGPA into equivalent marks, the equivalence would be established by dividing the candidate's CGPA by the maximum possible CGPA and multiplying the result with 100.
