All the successful candidates are required to register with National Skills Registry (NSR) at www.nationalskillsregistry.com and provide NSR registration number to POWERGRID. Candidates are required to get the following verified in their NSR profile at their own cost before joining or within 03 months of joining, failing which your engagement shall automatically be terminated without assigning any reason/notice whatsoever:

- Personal details like Identity, Bio-metrics (fingerprints)
- Essential Qualification i.e. - Post Graduation/Graduation/Diploma/Relevant Degree (as applicable)
- Previous employment/experience information

Upon joining, candidates shall be required to provide permission to POWERGRID to view their profile in NSR.

They are advised to go through the contents of the enclosed documents carefully and report for Pre-Employment Medical Examination along with Joining documents on the scheduled date.
