Sub: Acquisition of Vindhyachal Varanasi Transmission Limited by POWERGRID under TBCB route.

Dear Sir,

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, this is to inform that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on **16.10.2025** acquired **Vindhyachal Varanasi Transmission Limited**, the Project SPV to establish "Inter-regional (NR-WR) Transmission System strengthening to relieve the loading of 765 kV Vindhyachal-Varanasi D/c line", on build, own, operate and transfer (BOOT) basis from the Bid Process Coordinator – PFC Consultancy Limited (PFCCL).

The project comprises establishment of new 765 kV Sub-Station at Prayagraj in the state of Uttar Pradesh. The project also comprises 765 kV D/c Transmission Lines traversing in the states of Uttar Pradesh & Madhya Pradesh.

		Requisite approvals were obtained by the Bid Process Coordinator for transfer of VVTL.
		Approvals for Grant of Transmission License and Adoption of Transmission Charges are to be obtained from Central Electricity Regulatory Commission by VVTL after the acquisition by POWERGRID.
6.	Indicative time period for completion of the acquisition;	The entity was acquired as per the time lines furnished by Bid Process Coordinator.

Cost of acquisition and/or the price at which the shares are acquired;	The entity was acquired for an aggregate value of about Rs. 19.84 Crore including 10,000 equity shares at par at Rs. 10/- each along with assets and liabilities of VVTL as on the acquisition Date (16.10.2025). However, the acquisition price is subject to adjustment as per the audited accounts of VVTL as on the acquisition date.

VVTL shall be engaged in the business of transmission of power.  VVTL was incorporated on 16.04.2025 by Bid Process Coordinator. VVTL is yet to start commercial operation, as such no turnover has been recorded during last 3 years. VVTL will be operating in India.
