Dear Sir,

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is informed that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff Based Competitive Bidding, has on 28.03.2023 acquired "Bhadla Sikar Transmission Limited" (BSTL), the Project SPV to establish "Transmission system strengthening scheme for evacuation of power from solar energy zones in Rajasthan (8.1 GW) under Phase-Il Part-E", on build, own, operate and maintain (BOOM) basis from the Bid Process Coordinator - PFC Consulting Limited.

The Transmission system comprises establishment of a new 765kV D/C Transmission lines passing through the state of Rajasthan and bays extension work. The transmission system is an Inter State Transmission System Project and is to be completed in 18 months.

		Requisite approvals were obtained by the Bid Process Coordinator for transfer of BSTL.
		Approval for Grant of Transmission License and Adoption of Transmission charges are to be obtained from Central Electricity Regulatory Commission by BSTL after the acquisition by POWERGRID.
