**Sub: Acquisition of Bhadla Sikar Transmission Limited (BSTL) by POWERGRID under TBCB route.**

Dear Sir,

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is informed that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff Based Competitive Bidding, has on 28.03.2023 acquired "Bhadla Sikar Transmission Limited" (BSTL), the Project SPV to establish "Transmission system strengthening scheme for evacuation of power from solar energy zones in Rajasthan (8.1 GW) under Phase-II Part-E", on build, own, operate and maintain (BOOM) basis from the Bid Process Coordinator - PFC Consulting Limited.

The Transmission system comprises establishment of a new 765kV D/C Transmission lines passing through the state of Rajasthan and bays extension work. The transmission system is an Inter State Transmission System Project and is to be completed in 18 months.

Brief details of any governmental or regulatory approvals required for the acquisition;	BSTL was incorporated on 13/05/2020 by the Bid Process Coordinator as per the "Guidelines Encouraging Competition in Development of Transmission Projects" and "Tariff based Competitive-bidding Guidelines for Transmission Service" notified by Ministry of Power (MoP).  Requisite approvals were obtained by the Bid Process Coordinator for transfer of BSTL.  Approval for Grant of Transmission License and Adoption of Transmission charges are to be obtained from Central Electricity Regulatory Commission by BSTL after the acquisition by POWERGRID.
6.	Indicative time period for completion of the acquisition;	The entity was acquired as per the time lines furnished by Bid Process Coordinator.
7.	Cost of acquisition or the price at which the shares are acquired;	The entity was acquired with a net payment of about Rs. 23.76 Cr. and the acquisition includes 10,000 equity shares at par at Rs. 10 each as on the acquisition Date (28.03.2023). However, the acquisition price is subject to adjustment as per the audited accounts of the Company as on the acquisition Date.
8.	Nature of consideration - whether cash consideration or share swap and details of the same;	Cash Consideration as detailed at S. No. 7 above.
9.	Percentage of shareholding / control acquired and / or number of shares acquired;	100%
10.	Brief background about the entity acquired in terms of products/line of business acquired, date of incorporation, history of last 3 years turnover, country in which the acquired entity has presence and any other significant information (in brief).	The entity shall be engaged in the business of transmission of Power.  The entity was incorporated on 13/05/2020 by Bid Process Coordinator. The entity is yet to start commercial operation, as such no turnover has been recorded since its incorporation. The entity will be operating in India.
