Dear Sir,

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is informed that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff Based Competitive Bidding, has on 28.03.2023 acquired "Dharamjaigarh Transmission Limited" (DTL), the Project SPV to establish "Transmission scheme for evacuation of 4.5GW RE injection at Khavda PS under Phase II- Part B", on build, own, operate and transfer (BOOT) basis from the Bid Process Coordinator - PFC Consulting Limited.

The Transmission system comprises comprises of establishment of Bays extension works at 2 existing Sub-stations in the state of Chhattisgarh including creation of 220kV Voltage. The transmission system is an Inter State Transmission System Project and is to be completed progressively by March, 2025.

Brief details of any governmental or regulatory approvals required for the acquisition;	DTL was incorporated on 18/11/2022 by the Bid Process Coordinator as per the "Guidelines Encouraging Competition in Development of Transmission Projects" and "Tariff based Competitive-bidding Guidelines for Transmission Service" notified by Ministry of Power (MoP).  Requisite approvals were obtained by the Bid Process Coordinator for transfer of DTL.  Approval for Grant of Transmission License and Adoption of Transmission charges are to be obtained from Central Electricity Regulatory Commission by DTL after the acquisition by POWERGRID.
6.	Indicative time period for completion of the acquisition;	The entity was acquired as per the time lines furnished by Bid Process Coordinator.

Cost of acquisition or the price at which the shares are acquired;	The entity was acquired with a net payment of about Rs. 6.63 Cr. and the acquisition includes 10,000 equity shares at par at Rs. 10 as on the acquisition Date (28.03.2023). However, the acquisition price is subject to adjustment as per the audited accounts of the Company as on the acquisition Date.
