## Sub: Acquisition of ERWR POWER Transmission Limited (EPTL) by POWERGRID under TBCB route.

Dear Sir,

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is informed that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on 21.03.2023 acquired "ERWR POWER Transmission Limited" (EPTL), the Project SPV to establish "Inter-regional ER-WR Interconnection", on build, own, operate and transfer (BOOT) basis from the Bid Process Coordinator - REC Power Development and Consultancy Limited.

The Transmission system comprises of establishment of 400kV D/C Transmission lines traversing through the states of Orissa & Chhattisgarh and bays extension works. The transmission system is an Inter State Transmission System Project and is to be completed in 24 months.

Brief details of any governmental or regulatory approvals required for the acquisition;	EPTL was incorporated on 27/09/2022 by the Bid Process Coordinator as per the "Guidelines Encouraging Competition in Development of Transmission Projects" and "Tariff based Competitive-bidding Guidelines for Transmission Service" notified by Ministry of Power (MoP). Requisite approvals were obtained by the Bid
		Process Coordinator for transfer of EPTL.
		Approval for Grant of Transmission License and Adoption of Transmission charges are to be obtained from Central Electricity Regulatory Commission by EPTL after the acquisition by POWERGRID.
6.	Indicative time period for completion of the acquisition;	The entity was acquired as per the time lines furnished by Bid Process Coordinator.

Cost of acquisition or the price at which the shares are acquired;	The entity was acquired with a net payment of about Rs. 6.51 Cr. and the acquisition includes 50,000 equity shares at par at Rs. 10 each as on the acquisition Date (21.03.2023). However, the acquisition price is subject to adjustment as per the audited accounts of the Company as on the acquisition Date.
