Dear Sir,

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is informed that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on 21.03.2023 acquired "KPS3 Transmission Limited" (KPS3TL), the Project SPV to establish "Establishment of Khavda Pooling Station-3 (KPS3) in Khavda RE Park", on build, own, operate and transfer (BOOT) basis from the Bid Process Coordinator - REC Power Development and Consultancy Limited.

The Transmission system comprises of establishment of a new 765/400kV GIS, 765kV D/c Transmission Line and associated work in the State of Gujarat. The transmission system is an Inter State Transmission System Project and is to be completed in 21 months.

		Requisite approvals were obtained by the Bid Process Coordinator for transfer of KPS3TL.
		Approval for Grant of Transmission License and Adoption of Transmission charges are to be obtained from Central Electricity Regulatory Commission by KPS3TL after the acquisition by POWERGRID.
