## आज और कल तेज रफ्तार से चलेंगी हवाएं

नई दिल्ली। राजधानी में शुक्रवार और शनिवार को तेज रफ्तार से हवाएं चलने की संभावना है। हालांकि, दिनभर धूपे खिलेगी, जिससे सर्दी से मिली राहत बरकरार रहेगी। मौसम विभाग ने शुक्रवार को पहाड़ी इलाकों में बर्फबारी के साथ बारिश होने की संभावना जताई है। इससे शाम को सर्दी कुछ बढ़ सकती है।

मौसम विभाग के मुताबिक, बृहस्पतिवार को अधिकतम तापमान सामान्य से तीन अधिक 27 डिग्री सेल्सियस और न्यूनतम तापमान सामान्य से एक कम

सामान्य से तीन अधिक 27 डिग्री सेल्सियस रहा अधिकतम तापमान 10.2 डिग्री सेल्सियस् रहा। दिनभर धूप खिली रही और लोग धूप का आनंद लेते रहे। पिछले 24 घंटे में हवा में नमी

का स्तर 28 से 96 फीसदी तक दर्ज किया गया। अगले 24 घंटे में मौसम साफ रहने के साथ 20 से 30 किमी प्रतिघंटे की रफ्तार से हवाएं चल सकती हैं। अधिकतम तापमान 27 और न्यूनतम तापमान 10 डिग्री सेल्सियस तक दर्ज किया जा सकता है। शनिवार को भी तेज हवाएं चलने की संभावना है।
