It is informed that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on 19th December, 2019 acquired Meerut-Simbhavali Transmission Limited (MSTL), the Project SPV to establish transmission system for "Transmission System for Construction of 765/400/220 kV GIS Substation, Meerut with associated lines and 400/220/132 kV GIS Substation, Simbhaoli with associated Transmission lines", on build, own, operate and maintain (BOOM) basis from PFC Consulting Limited (the Bid Process Coordinator).

The transmission system comprises 765kV and 400kV transmission lines apart from establishing a new 765/400/220 kV Substation at Meerut, Uttar Pradesh and, a new 400/220/132 kV Substation at Simbhaoli, Uttar Pradesh. The transmission system is an Intra State Transmission System Project of Uttar Pradesh and is to be progressively constructed by August, 2021.
