## Sub: Regulation 30 of the SEBI (LODR) Regulations, 2015

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is informed that:

- (A) Power Grid Corporation of India Limited has been declared as the successful bidder under Tariff based competitive bidding to establish transmission system for Construction of Ajmer (PG)-Phagi 765 kV D/C line along with associated bays for Rajasthan SEZ on build, own operate and maintain (BOOM) basis. The Letter of Intent (LoI) dated 29<sup>th</sup> August 2019 has been issued to Power Grid Corporation of India Limited. The Transmission system will traverse the State of Rajasthan; and
- (B) Power Grid Corporation of India Limited pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on 29<sup>th</sup> August, 2019 acquired Khetri Transco Limited (KTL), the Project SPV to establish Transmission System associated with LTA application from Rajasthan SEZ (Part -C), on build, own, operate and maintain (BOOM) basis from REC Transmission Projects Company Limited (the Bid Process Coordinator).

The transmission system comprises 765kV and 400kV lines apart from establishing a new 765/400kV Substation at Khetri, Rajasthan. The transmission system is an Inter State Transmission System Project and is to be completed by December 2020.
