Fatigue, breathlessness: New clinic to address issues after Covid recovery

ASTHA SAXENA

NEW DELHI, AUGUST 22

FROM MOHALI to Delhi, patients are calling the first of its kind post-Covid clinic set up at Delhi government's Rajiv Gandhi Super Specialty Hospital to seek guidance on the several health ailments they are facing after recovering from Covid-19.

In the two days since it became operational, the clinic, which aims to support Covid patients who have recovered from the illness, has responded to over 20 patients from Delhi as well as cities such as Aligarh, Agra, Moradabad and Mohali, who are keen to know the medications for post-Covid issues.

'So far, most of these patients are complaining about breathlessness, mild exertion, weakness, and fatigue. Patients feel that their quality of life is getting compromised as they are unable to get into their regular routine," said Dr Ajeet Jain, nodal officer



The clinic has so far seen over 20 patients from Delhi as well as cities such as Aligarh, Agra, Moradabad and Mohali

of the clinic at the hospital.

The concept of a post-Covid clinic was initiated when, as a regular policy, the hospital administration started contacting patients who had already recovered from the virus, and were informed that they are facing various issues. According to officials, the clinic is in line with Chief Minister Arvind Keiriwal's vision

of providing a helping hand to patients who have recovered. The government is also providing oxygen concentrators to patients who are facing issues in maintaining the oxygen saturation levels even after getting discharged from the hospital.

The Rajiv Gandhi Super Speciality Hospital has discharged around 1,500 patients and the doctors are calling each of them to follow-up. "This will help us have definite data on the

impact of Covid on the human body. Through this clinic, maybe after a month, we might be able to analyse the data which can act as a base for the future treatment," said Dr B L Sherwal, medical director of the hospital.

Among 3 arrested for robbery, engineer who lost job in Qatar

EXPRESS NEWS SERVICE NEW DELHI, AUGUST 22

DELHI POLICE have arrested three men, including an engineer who lost his job in Qatar due to the Covid-19 pandemic, for allegedly posing as cops and robbing people in Dwarka's Najafgarh area Saturday. Police identified the accused as Swapnil Lalkishor, the engineer, and his friends Keshav and Ravi.

According to police, the accused, wearing police uniforms and carrying walkie-talkie sets, allegedly posed as policemen and pretended to patrol the streets in Najafgarh on August 18.

Late at night, they allegedly stopped a Verna car, which had a Punjab registration plate. The victims thought they were checking their vehicle, but were The accused, wearing uniforms and carrying walkie-talkies, allegedly posed as policemen

soon abducted. The accused took the two men in their black Creta car and robbed their jewellery, phones, cash and other belongings. They were later dropped off at Singhu border.

A senior police officer said that Lalkishor and his friends allegedly tried to extort more money from the victims by forcing them to call their relatives, but could not get anything.

(Dwarka) Anto Alphonse said, "We received a complaint from the victims and started tracing the route taken by the accused. More than 100

CCTV cameras were checked and the car was traced to Loni. We went there and arrested two men; the third accused was arrested from Rani Bagh.'

During questioning, Lalkishor told police that he returned from Qatar recently and wasn't comfortable with his life here. He wanted money, so he roped in his friend, Keshav Sehgal, a property dealer, and allegedly hatched the plan. Sehgal also asked his friend Ravi, who worked at a call centre and needed money to pay medical bills for his mother's opera-

tion, to join them, police said. Lalkishor took his brother's Creta car and the three ventured on different roads to find a suitable "target".

Sanitary napkins for Re 1 — but many don't know about it

AT 10 am every day, Pravesh Kumar Dhama opens his Jan Aushadhi Kendra, situated in Ashok Nagar, and patiently awaits customers. Prime Minister Narendra

Modi's announcement of sanitary pads for Re 1 has had little effect in his area, he says, as he points to the boxes of sanitary pads lying around on the shop floor, untouched. "Sometimes, we manage to

sell around 100 sanitary napkins in a day, but that is mostly to NGOs or other such organisations. But on most days, very few people come to buy. People visit the store from areas such as Khora colony and Trilokpuri," he

Since the lockdown, many women who relied on government schools for sanitary napkins, have switched to ordinary

An interaction with women staying just down the road from Dhama's shop revealed that most are still unaware of the cheaper alternative at the Jan Aushadhi Kendra. Most of them said that it has

become difficult to buy sanitary napkins since their daughters stopped going to school.

Class XII student Priti Sharma (19) was among those who used to collect sanitary napkins from school. "Now we have online classes so we don't have a choice but to buy sanitary napkins. I tried using cloth a few times but it was very uncomfortable. So I started buying packets at Rs 30

Her mother, Sushma Devi Sharma (48), has returned to us-

ing cloth like she would when she was younger. "My husband is unwell and I am a housewife. We are financially dependent on my son who works as a tailor. Obviously, we cannot afford pads for two women, so I use old pieces of cloth."

The family was unaware of sanitary napkins being sold at Jan Aushadhi Kendras for Re 1 each.

A few women, however, knew of the Jan Aushadhi Kendra, and had started going there during the lockdown. Suman Kumari (43) said, "I started buying from the kendra since both my daughters stopped attending school due to the lock-

down. It is a cheaper alternative." Dr Surbhi Singh, gynecologist and founder of NGO Sachhi Saheli, said, "It took some time for subsidised sanitary napkins sold by the kendras to pick up. Recently, many people have donated these pads to the NGO. I have distributed them among needy women across the city. Some gave positive feedback, while others said that they are not very comfortable as they are smaller than napkins made by other companies.

"Registered bonafide senior PhD students, whose presence in the research laboratory is essential, may join their research laboratories after obtaining a certificate from their respective supervisors and further endorsed by the Head of the Department or the Director of the Center to this effect," read a notice by proctor Neeta Sehgal on this matter.

According to this, the total

number of students in a research lab at any given time should not be more than two or three.

Other generic safety precautions they have been advised to take are "social distancing, face mask, sanitisation, etc while entering the academic area and while working in their respective research laboratories".

Earlier this week, the university had also issued a notice allowing for the phased return of PhD students to their hostels, beginning with senior PhD students. The returning students will have to undergo a 14-day mandatory self-quarantine in their hostel rooms, and will be screened by the university's health centre following that.

आरोपी गोलू काजी आए दिन हिंदू धर्मावलंबियों को आहत करने वाली पोस्ट फेसबुक पर डालता रहता है। शिकायत में कहा गया कि 20 अगस्त को राम मंदिर के संबंध में फेसबुक पर विवादित पोस्ट डालकर धार्मिक भावनाओं को आघात पहुंचाया गया है। पुलिस अधीक्षक ने बताया कि मामला संज्ञान में आते ही पेटलावद थाने में धारा 505 (2) के तहत मामला दर्ज कर एक घंटे के भीतर आरोपी

CBI recreates sequence of events on July 14

A CBI team investigating the Sushant Singh Rajput abetment to suicide case recreated the sequence of events that took place July 14 - the day he died by suicide — at his Bandra bungalow over Saturday and Sunday.

The agency also went to the Waterstone resort in Andheri East, where the actor had stayed for two months last year.

Further, the CBI has sought the help of forensic experts from AIIMS, Delhi, to go through Sushant's Cooper hospital postmortem report that had ruled out foul play in his death.

An official said that a team from the CBI, along with those present at Sushant's Bandra residence on the day of suicide, including his friend Siddharth Pithani and house staffers, went to the flat for recreation of the sequence of events.

multi-specialty hospital. On May 21, the Maharashtra government had passed a notification reserving 80 per cent beds in private hospitals for Covid-19 patients and introduced a price cap on their treatment. As per the notification, while a patient in the isolation ward cannot be charged more

than Rs 4,000 per day, those in intensive care units (ICU) needed to shell out Rs 7,500 per day. Ventilator charges were capped at Rs 9,000 per day.

TMC officials said they started receiving complaints about overcharging from June.

Swastik Hospital was one of the first to come under its radar in June for charging its patients in violation of government's fixed rates. Following complaints, MNS leader Sandeep Pachange met TMC Deputy Commissioner Vishwanath Kelkar and demanded strict ac-

tion against the hospital. In July, TMC began a full-fledged drive against other private hospitals. On July 25, Horizon Prime hospital on Ghodbunder Road was the first to be sealed for a month and prohibited from treating Covid-19 patients after an audit showed the hospital was inflating its bills and charging extra for personal protective equipment and treatment. Of its 57 bills scrutinised, 56 bills were found inflated.

However, TMC decided to allow the other 17 hospitals under audit to carry on with its operations. "Our aim is to not stop these hospitals from functioning, as there is a huge burden on the health resources. We have instructed the hospitals to refund the money to patients, which is more important at this point," said Thane Commissioner Dr Vipin Sharma. He added that the eight teams of auditors will continue its scrutiny of hospitals bills in Thane.

"We have demanded strict action against the 17 these hospitals so that people can afford Covid-19 treatment without any hassle," Pachange said.

When contacted, Metropol hospital's administrative official Anil Tribhuvan said, "We did not overcharge Covid-19 patients. We only charged as per our rates."

In Titan hospital, administrator Dr Shahrjan Singh said, "We are not overcharging patients, TMC auditor for clarification."

suburban trains are being operated in Central, Western and Harbour lines only for those employed in essential sectors, including employees of state and Central governments.

Recently, the government had allowed accredited journalists to travel by suburban trains for which a QR code will be provided.

Operations of suburban trains have been shut for people since March this year. PTI
