In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, this is to inform that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on **24.03.2025** acquired **Kurnool-IV Transmission Limited**, the Project SPV to establish "Transmission System for Integration of Kurnool-IV REZ - Phase-I (for 4.5 GW)", on build, own, operate and transfer (BOOT) basis from the Bid Process Coordinator – REC Power Development and Consultancy Limited (RECPDCL).

The project comprises establishment of new 765 / 400 / 220kV Kurnool IV Pooling Sub-Station and augmentation of transformation capacity at existing C'peta Substation in the state of Andhra Pradesh. The project also comprises 765kV and 400kV D/C Transmission Lines traversing in the states of Andhra Pradesh and Karnataka.

Brief details of any governmental or K-IVTL was incorporated on 20.11.2024 by the Bid regulatory approvals required for the Process Coordinator as per the "Guidelines acquisition; Competition in Development Encouraging Transmission Projects" and "Tariff based Competitivebidding Guidelines for Transmission Service" notified by Ministry of Power (MoP). Requisite approvals were obtained by the Bid Process Coordinator for transfer of K-IVTL. Approvals for Grant of Transmission License and Adoption of Transmission Charges are to be obtained from Central Electricity Regulatory Commission by K-IVTL after the acquisition by POWERGRID. Indicative time period for completion K-IVTL was acquired as per the timelines furnished by of the acquisition; Bid Process Coordinator. 7.
