Sub: "Notice for Regulation of power supply" for default of BRPL in making payment of outstanding dues and opening Letter of Credit

Ref: 1. Our Letter no. CC:Comml:BRPL dtd 23.02.2015. 2. Our Letter no. CC:Comml:BRPL dtd 10.03.2015

- BRPL is a designated Inter-State Transmission System customer (DIC) who is using ISTS network for transfer of power from various power plants located in different parts of country to Delhi and is under obligations to make timely payment of transmission tariff and to open requisite Letter of Credit towards payment security mechanism in line with Agreements, Acts and Regulations.
- 2. It is, however, a matter of serious concern that BRPL is not making full payment against the monthly bills raised on it towards transmission tariff as per their commitments and regular follow-up & our correspondence as referred above. As a consequence, total dues of BRPL have grown to a huge amount of Rs 142.10 Cr as on 17.03.2015, which includes an amount of Rs 69.47 Cr. that is outstanding for more than 60 days as may be seen from the copies of bills available with BRPL.
- 3. Further, the LC has also to be been established by BRPL for an amount of Rs 64.19 Cr. that is also long overdue, despite repeated reminders and follow up.
- 4. Ours is a commercial organisation and huge outstanding dues as brought out above are seriously affecting our cash flows and causing adverse impact on our abilities to carry on our business enterprise and to fulfil our loan repayment liabilities towards creation of transmission assets. Other ISTS Licensees are also facing similar cash flow problems.
- 5. Regulation 4 of CERC (Regulation of Power Supply), 2010 reads as under:-

"In case of outstanding dues or in case the letter of credit or any other agreed Payment Security Mechanism is not maintained as per the Agreement, the generating Company or the transmission licensee, as the case may be, may serve a notice for regulation of power supply, on the Defaulting Entity, for reducing the drawl schedule in the case of the generating company or withdrawl of open access / access to Inter-State Transmission System in the case of the transmission licensee.

- In view of default of BRPL, this "Notice for Regulation of Power Supply" is being issued as per the provisions of Regulation 4 of CERC (Regulation of Power Supply) Regulation 2010 & provisions of BCD procedure approved by CERC and terms of TSA.
- 7. The regulation of power supply of BRPL through their Long Term Access shall be effected as follows:-

 Quantum of power to be : regulated

20% of Power drawl of BRPL through ISTS

network.

 Commencement of : Regulation of Power supply

From 00.00 Hrs of 28.03.2015

Period of Regulation of :

Power supply

Initially for 2 months or till clearing of the entire dues outstanding for more than 60

days

• Source of regulation of :

Power Supply

To be regulated from various Power plants of NTPC and NHPC. Plant-wise details

shall be furnished by 25.03.2015.

- The regulation of power shall be carried out through Northern & Eastern Region Transmission Corridors.
- All other liabilities of BRPL shall be as per the provisions of CERC Regulations
- 8. Through a copy of this Notice, NRLDC is being requested to prepare implementation plan for Regulation of Power Supply of BRPL and implement the same w.e.f. 00:00 Hrs. of 28.03.2015 as per the details to be furnished by 25.03.2015.
- In view of above, it is requested to liquidate our outstanding dues and open LC as per above by 24.03.2015 failing which regulation of your power supply shall be enforced as stipulated above.
