Sub: Default of PDD, J&K in making payment of outstanding dues – Notice regarding

- You are aware that around 80% power requirement of the State of J&K is met by PDD,J&K by drawing power from National Grid. Accordingly, PDD, J&K is under obligation to make timely payment of monthly Inter-State Transmission System (ISTS) tariff for the same so that ISTS services are continued uninterruptedly.
- 2. It may, however, be mentioned that despite regular follow-up, visits and correspondence by POWERGRID, payment by PDD, J&K against the monthly bills is quite irregular and is a matter of serious concern for POWERGRID(CTU). As a consequence of delayed payment/non-payment, total dues of PDD, J&K have accumulated to a huge amount of Rs 323 Crore as on 17.08.2015, as may be seen from the copies of bills available with PDD, J&K. Out of above, an amount of Rs 243 Crore is outstanding for more than 60 days and attracting late payment charges.
- In addition to above outstanding dues, PDD, J&K have also not established the LC for Rs 36 Crore towards payment security mechanism till date despite our repeated requests in this regard.

- 4. We regret to point out that, such huge outstanding dues, which are kept on increasing month over month, are seriously affecting our cash flow and causing adverse impact on our abilities to carry out normal business activities besides affecting our abilities to fulfill our loan repayment liabilities towards lenders. Other ISTS Licensees, whose transmission system is part of National Grid, are also facing similar cash flow problem to meet their obligations.
- In view of the situation explained above, PDD, J&K is requested to liquidate all the dues exceeding 60 days (Rs 243 Crore) latest by 3rd Sept, 2015. In case of non- payment of outstanding dues as per above, we would be left with no other option but to restrict the access of PDD, J&K to the National Grid for drawl of power by Regulation of their Power Supply from the grid. Consequently, regulation of power supply of PDD, J&K shall be carried out from the Northern Region Transmission Corridor, as per the following:-

In view of above, it is requested through this 'Notice' to make payment of Rs 243 Crore towards outstanding dues as per above by 3<sup>rd</sup> Sept, 2015 so as to enable us to continue to provide PDD, J&K the full access to the National Grid for drawl of power.
